ABR data – assisting government agencies

Business data is the cornerstone for government planning and decision making. The Australian Business Register (ABR) has a comprehensive database of business information that can provide your government agency with the clarity and confidence needed to achieve the best results.

What is ABR data?

When businesses and other organisations – including government bodies and non-profit organisations – apply for an Australian business number (ABN), their registration information is captured and stored in the ABR.

There are two kinds of data stored in the ABR – **public and non-public**. Only eligible government agencies can access non-public data in addition to public data.

Non-public data includes, but is not limited to:

- business address
- email address
- phone number
- ANZSIC code
- industry description
- authorised contact
- · associate details
- · geocoded business locations.

ABR data is available to you 24 hours a day, 7 days a week. Better yet, it's free.

How non-public data can help your agency

Our non-public data allows your agency to understand and assist businesses and the wider community in your area – as well as strategically plan for the future.

It also provides your agency with an opportunity to increase your productivity and savings through reduced workflow.

Here's how non-public data is commonly used:

- Service delivery validate client information in real time and pre-fill online forms
- Procurement validate supplier ABNs and identify local suppliers and trades people
- Planning and economic development – identify and plan for growth in the community
- Licensing businesses validate business details, and issue licences and registrations
- Emergency management identify businesses affected by natural disaster
- **Disaster recovery** assist in locating businesses eliqible for disaster grants
- Compliance undertake regulatory compliance, investigations and enforcement
- **Training and education** identify target groups for training workshops
- Community consultation engage with local businesses on community issues
